

CAGONT Annual Report 2010

The annual meeting was a great success this year! The Department of Geography (Faculty of Arts) and the Centre for the Study of Commercial Activity (Ted Rogers School of Management) at Ryerson University welcomed 192 attendees (112 graduate students; 30 undergraduates; 31 professors/professional members; and 19 others) to the CAGONT 2010 Annual Meeting from October 15-16, 2010, in Toronto, Ontario. This tied the existing attendance record for a CAGONT annual meeting. At the meeting, 107 papers (new record) were presented; this included 94 oral paper presentations (new record), 11 poster presentations, and 2 special session paper presentations. The CAGONT 2010 organizing committee was very pleased that **Dr. Nigel Waters** - **Director, Geographic Information Science Center of Excellence (GISCE) and Professor of Geography and Geoinformation Science, George Mason University** accepted the invitation to be the plenary speaker at CAGONT 2010. His talk 'Including Diversity: GIS Methodologies and Paradigms in the Big Tent' was attended by approximately 70 people and followed by a reception on October 15. Other Friday activities included a Department Chairs meeting, a CAGONT executive meeting and the first special student session on *Field Trip Planning: A Geography Signature Pedagogy*.

The Service to Ontario Geography Award for significant and lasting contributions to scholarship, teaching and broader service to Geography in Ontario was presented to **Dr. Jean Andrey - University of Waterloo** by outgoing CAGONT President **Dr. Bill Crumplin - Laurentian University**. It seems only appropriate that the Canadian Association of Geographers – Ontario Division (CAGONT) recognizes Jean for her accomplishments at a CAGONT annual meeting. Dr. Marilyne Jollineau - Brock University was elected the new CAGONT President, while **Chelsea LeBlanc - Brock University** was elected as the new Student Representative on the CAGONT Executive.

In preparation for the annual meeting later this year, the Executive would like to remind students that a pool of money has been set aside to fund student travel to the CAGONT Annual Meeting. This money is available to all student CAG members (Student membership in the CAG only costs \$45 so this is a very good investment!) - (Ph.D., Masters and undergraduate) travelling to the conference to present a paper. Students must be preregistered. They will receive their registration fees back after the meeting (if they apply for it and submit proper documentation). Travel costs will be reimbursed. Students must supply receipts for travel (e.g., by rail, bus, or car). The pool of money will be distributed among applicants based on distance travelled. Applications must be approved by the Chair of the student's department.
